

## U.S. Law and Legal Writing Seminar - July 10 - August 2, 2017

The U.S. Law and Legal Writing Seminar is designed to provide an overview of U.S. Law while strengthening legal research and writing skills. Designed for international students interested in understanding U.S. law while spending 4 weeks in beautiful Malibu, California.

In addition to the above described topic areas, the program includes weekly extra-curricular professional and cultural activities. Past excursions have included Universal Studios, the Hollywood Bowl, the John Paul Getty Museum, and a Dodgers baseball game, as well as professional trips to Los Angeles Superior Court, JAMS, an interview with a sitting judge, and a panel discussion with lawyers with specialty in international law practice.

## Mediating the Litigated Case - July 31 - August 5, 2017

This basic mediation training will focus on the various stages of the mediation process, identifying and working with different negotiation styles, and facilitating problem solving regardless of whether the case involves contractual, tort, personal injury, employment, partnership, or securities issues.

In addition to providing mediation skills training, the program will deal with issues specific to the adversarial setting including managing attorney advocates, the parameters of confidentiality, and concerns about discovery. It will also focus on issues of particular concern to attorney-mediators including the proscription against dual representation, providing legal advice, conflicts of interest, drafting mediation agreements, and other ethical dilemmas.

This program will provide Peking University students with the ability to learn from practicing mediators and attorneys.

Both programs are traditionally available for \$7945, but Peking University students will be able to register for both programs at a discounted price of **\$3,500**, which includes housing on campus.
